- 1. Facility of Online Registration & Documents verification, confirmation of Application Form for Admission to Seats other than CAP Seats shall be continued till the Cut off date of admission.
- 2. The candidates aspiring for admission for Institutional Quota, seats remaining vacant after CAP, it is **mandatory** to get registered, documents verified and confirmation of application either by <u>E-Scrutiny Mode or Physical Scrutiny Mode</u>. Such candidates must apply separately to Institutes for admissions. Merit of such candidates shall be prepared by the Institute at the institute level.
- 3. Candidates who have opted <u>Physical Scrutiny Mode</u> can avail the IT facility which is available at Facilitation Centre (FC) free of cost for submission, scanning and uploading documents, and confirmation of Application form. The candidate shall adhere to the COVID-19 guidelines issued by the GoM time to time during reporting at the FC.
- 4. For <u>Physical Scrutiny Mode</u>: List of FC's is available on website and these FC's shall remain open during the schedule between 10.30 a.m. to 5.30 p.m.
