Ministry of Minority Affairs, Government of India is offering the **Merit cum Means Based Scholarship (MCM)** for 5797 economically weaker and meritorious students belonging to **Muslim, Sikh, Buddhist, Christian, Parsi and Jain** minority communities pursuing Professional and Technical courses.

Online Applications are invited only through “**National Scholarship Portal**” ([website-www.scholarships.gov.in](http://www.scholarships.gov.in)) for Fresh/Renewal Scholarship for academic year **2017-2018**. Applicants /Institutes are advised to go through the **FAQ** before filling the scholarship application form/Scrutiny of application form. **(All details are available on National Scholarship Portal)**

#### ❖ **Eligibility Criteria :**

1. An Indian national student, domicile of **MAHARASHTRA** will be entitled for scholarship under the **quota of MAHARASHTRA** only irrespective of his place of study.
2. A student must be **bonafide student** of Institute.
3. Admission to the course should be through Common Entrance Test or obtained minimum 50 % marks at qualifying examination.
4. Applicant should not avail any other scholarship / stipend.
5. The total annual income of family/ guardian should not be more than **2.50 Lakhs**.
6. 30 % seats are reserved for girls.

#### ❖ **Required Scanned Documents that is to be Online Uploaded :**

As per the online filled information by the student for FRESH /RENEWAL scholarship, Detail list of required document will be shown by the portal before finalizing of application form by the student. Student has to scan their own required documents and upload it (**Uploaded scanned documents should be clearly readable**).

[**Note:** After Finalizing duly filled-in online application form, Students may also be advised to take print-out for reference]

#### ❖ **Courses for Scholarship :**

The professional and Technical courses Degree in Engineering/Technology UG & PG ( B.E. / B. Tech/ M. E. / M. Tech), Cement Technology, Fashion Technology, Pharmacy ( B. Pharm / M. Pharm), Architecture & Town Planning ( UG & PG), Hotel Management & Catering Technology, Applied Art & Craft ( UG & PG), MCA, MBA/MMS, Health Science Courses, Law (LLB/LLM), Veterinary Sciences and Animal Husbandry etc.

**❖ Scholarship Amount :**

**❖ Students Bank Details and Aadhaar card number :**

<b>Note : It is informed to the candidate, before Filling Application Form / Transferring of Scholarship Amount in Bank Account , Candidate has to ensure that ,</b>
1. Name on account no. should be same as per the candidate name in scholarship application form.
2. IFSC Code and Account Number of candidate should be correct.
3. <b>In Bank</b> , Aadhaar card number should be <b>seeded/ linked</b> with the submitted bank account no.
4. Bank account no. should not be stopped / closed before transferring the scholarship amount. (i.e. it should be operative)
5. Bank account no. should not have any fixed credit limit (i.e. sanctioned scholarship amt. can be permissible to credit in account.)
<b>In Bank Account , Sanctioned scholarship amount will be transferred through "Public Finance Management System" If Sanctioned scholarship amount can't be transfer due to invalid bank details of the candidate's then it may be surrendered.</b>

**❖ Submission of Online Application Form for Fresh / Renewal Scholarship by the student :**

On the home page of National Scholarships Portal : ( [website-www.scholarships.gov.in](http://www.scholarships.gov.in) ) for ,

**A) Fresh Application :**

1st step - Student have to go with the option "New User ? Register Now" , Fill up the application as per the instructions given by the system then click on register button. After registration student will get an "Application ID".

2nd step - By using received Application Id go with the option "Apply for Fresh" and then fill the subsequent details to finalize the application form.

**B) Renewal Application :**

Students have to go with the option "Apply for Renewal" and through log-in by using the application id of previous year ( Student can also use Forgot Registration ID to retrieve their ID) fill the subsequent details as per the instructions given by the system to finalize the application form.

**❖ Online Scrutiny of Application by the Institute :**

The Registered institutes go through the [website-www.scholarships.gov.in](http://www.scholarships.gov.in) and log-in by using the Institute/User\_ ID and password provided to them and do the online Scrutiny without keeping it pending. Once the Scanned Documents have been verified successfully , then the Institute has to forward the application to the next level before last date of scrutiny.

[Note: Only Scrutinized Application form by the institute up to the last date of Scrutiny will be considered for Generation of Merit List.]
