CIRCULAR

REFUND OF SEAT ACCEPTANCE CHARGES

Instructions regarding remittance of Seat Acceptance Charges to the Institute against the Candidates who have deposited Seat Acceptance Fees and not reported to Allotted Institutes for A.Y. 2016-17.

As per the provision given in the Rule No 12 of the Information Brochure for academic year 2016-17, State CET Cell, Mumbai has collected Seat Acceptance fees against the confirmation of the seat allotted through CAP to the candidate in the form of Demand Draft at ARC.

For Undergraduate/Post Graduate programmes, the seat acceptance fees are Rs. 5,000/- for Candidates of General Category, VJ/DT, NT, SBC/OBC Category and Rs. 1,000/- for SC, ST Category Candidates. For Diploma Programmes the seat acceptance fees are Rs. 3,000/- for Candidates of General Category, VJ/DT, NT, SBC/OBC Category and Rs. 1,000/- for SC, ST Category Candidates.

As per the provision in the rule, the fees collected as seat acceptance fees is being transferred to the respective institute by deducting Rs. 1,000/- towards processing fee against each candidate who have reported to the respective institute for admission through CAP.

The Procedure of remittance of Seat Acceptance fees to Institute is given below: -

The Institute shall collect the single cheque of amount pertaining to the all programmes, all courses in that Institute from the respective Regional Offices of Technical Education on 11/04/2017 onwards, for which Institute shall report to the RO as per the schedule.

In case of the institutes for which the Net Amount payable for State CET Cell is negative, such institutes have to pay that amount to the CET Cell in the form of DD or through RTGS through RO before collecting the Stale DD from the RO.

RO should transfer such amounts to the A/C of State CET Cell and details of the same to be furnished to State CET Cell.

The Institute is provided with the following -

- 1. The cheque amount is calculated by considering the amount (deposited through valid DD) minus the processing fees of all candidates admitted in the institute irrespective of those candidates whose DDs are not realised (Stale) due to expiry.
- 2. List of Candidates who have reported to Institute for admission and whose DDs are not realised (Stale) due to expiry.
- 3. Stale DDs

All Institutes have to follow following procedure for Stale DD-

- a. Hand over Stale DDs to respective candidate and instruct them to cancel the DD from the bank from where it is issued.
- b. Collect the amount of Stale DD from the Candidate against the seat acceptance fees which will be retained by the Institute.
