

The Department of Higher & Technical Education in Ministry of Human Resource Department of Government of India is publishing the statistical information of Higher Education every year. National University of Education Planning and Administration(NUEPA) has set up the Project Unit for the All India Survey on Higher Education for MHRD. The NUEPA has communicated, vide letter (http://www.dte.org.in/download/National_university_newdelhi.pdf) under reference, to the Directorate to write to each PGDM and Diploma Institute (institute not affiliated to University) to collect and upload their relevant data. A portal has been developed by NIC (URL : <http://aishe.gov.in> or <http://aishe.nic.in>) on which all the survey related information is available.

The institutes were directed to go through the letters under reference No. 2/3, regarding registering their name on portal with Role as "Institute-STB/DTE-Officer".

The Department of Higher Education, Ministry of Human Resource Development, New Delhi has taken the review of the project on 29th Feb 2012 and set the dead line as 31st March 2012. The list of the institute who has not registered on AISHE Portal is attached herewith. The principal of the institute is directed to report to the Regional Office and get registered without fail by 25th March 2012 and upload the filled data by 31st March 2012. The data is important as the National and State level for planning and hence punitive actions shall be taken against the institute not submitting the data.
