**Subject: Communication of seats available for admission to Direct Second Year Engineering/
Pharmacy for the year 2012-13**

The admissions to Direct Second Year Engineering / Pharmacy shall be carried out through multiple CAP Rounds for the academic year 2012-13. The Directorate is adopting the Online Application System for submission of Application form, option form, allotment and Reporting. The rule for calculating the Coursewise number of seats available for admission through CAP is given in the Information Brochure, available on DTE website.

The institute should Log On to the Online System through the Institute Code and Password provided by the DTE and update the information pertaining to No. of seats available for admission through Online System by updating the status of the candidates. The internal transfers shall be done by engineering institutes. The Online System shall validate the information and generate the report. Message facility is provided to communicate with Regional Office or DTE office. The Un Aided Minority institutes should update the status of the candidates and communicate the No. of seats to be filled amongst Minority Candidate at institute level and to be filled through CAP.

The institute shall confirm the Number of seats available for admission through CAP only after ensuring the correctness of the data. Once this data is confirmed, it cannot be altered / changed. The System shall generate the Online Report of Number of seats available for admission through CAP and Minority. The head of the institute shall certify it by affixing his signature and institute seal. This report is to be submitted to the concerned Regional Office of the Technical Education as per schedule given below.

The Regional Office shall do the entry of the transferred permitted by Regional Offices after verifying the status of transfer/joining. They shall verify the data and confirm the Number of seats available for admission through CAP of an institute through Login of Regional Office. The System shall generate receipt of confirmation of Number of seats available for admission through CAP.

The Directorate shall enter the transferred candidates approved by DTE at the Directorate level. The vacancy position available through Online System shall only be considered for CAP. It shall be responsibility of the institute to update correct information; otherwise action shall be taken as per the rules mentioned in the brochure for 2012-13. The vacancy position shall change due to the transfers.
