Sub: Issue of Invalid/State Demand Draft to respective Institute

Dear Sir,

With reference to the Circular mentioned above, the following activities regarding Refund/transfer of fees were carried out.

1. **Refund of fees through ARC to those candidates who have not reported to the Institutes –** Pre-printed pay orders were given to ARC to handover to the respective candidates.
2. **Amount of fees to be transferred to respective Institutes through RO–**Pre-printed pay orders of amount (considering only valid DD). Invalid DD of the admitted candidates were also delivered to the respective Institutes through RO.

With reference to the point No 2 above, this office has received complaints from the institutes regarding wrong entries of the admitted candidates in the courses like DSE & DSD. These errors are identified by this office and accordingly following corrective measures required to be taken through the respective Regional offices.

**Case 1: - Invalid DD of candidates were received by the institutes to which the candidates were not admitted.**

Corrective measure for case 1: - Such Institutes shall return such invalid DD (not belonging to them) to State CET Cell, Mumbai.

**Case 2: - Less number of Invalid DD are received by the Institutes.**

Corrective measure for case 2: - Such Institutes shall report such cases with list of the candidates (Whose DD were not received) to State CET Cell, Mumbai.

**Case 3: - Less Refund amount received by the Institute**

Corrective measure for case 3: - Such Institutes shall report such cases with list of the candidates to State CET Cell, Mumbai.

**Case 4: - Extra Refund amount received by the Institute**

Corrective measure for case 4: - Such Institutes shall report such cases with list of the candidates (not belonging to them) & submit DD of extra amount in the name of "Commissioner, State CET Cell, Maharashtra State, Mumbai" to State CET Cell, Mumbai.

With reference to the point No 1 above, the ARC's who could not handover the pay orders of the candidates (Not Reported) or candidates did not turn up for the collection of the pay order, such undelivered pay orders are required to be handed over to the State CET Cell at the earliest.
